### 9.6 Additional Privacy Notice for Residents of Mexico

This Additional Privacy Notice for Residents of Mexico ("Mexico Privacy Notice") supplements our Privacy Policy and applies solely to residents of Mexico. We adopt this Mexico Privacy Notice to comply with the Federal Law on the Protection of Personal Data held by Private Parties (Ley Federal de Protección de Datos Personales en Posesión de los Particulares ("LPD")), its corresponding regulations, and applicable guidelines.

# Responsible Entity

Global Finishing Solutions, LLC ("GFS"), located at 12731 Norway Road, Osseo, WI 54758, USA, is the entity responsible for the collection and use of your personal information.

### Collection of your Personal Information

Please see Sections 2 and 3 of our Privacy Policy for a description of the personal information we collect and use. Be advised that GFS does not collect sensitive personal information such as your political opinions or affiliations, health information, racial or ethnic origin, and/or religious or philosophical beliefs. GFS may collect personal financial and economic information, but does not use or share such information except in connection with the processing of payments or pursuant to another legal basis.

### Use of your Personal Information

As further detailed in Sections 3 and 4 of our Privacy Policy, we use the personal information that we collect for the following primary purposes:

- To provide you with the requested product(s) or service(s), and to invoice and collect payment for those products and services;
- To provide you with the requested support or otherwise fulfill your request;
- To manage our relationship with you, including being able to contact you;
- To help us improve and further develop our website, products, and services;
- To personalize your website experience;
- To protect the security or integrity of our website;
- To conduct research and analytics;
- To meet our legal obligations;
- To protect and defend our rights and the rights of others; or
- Other purposes that we provide you notice of at the time of collection.

In addition, as noted in Section 3.3 of our Privacy Policy, we may use your personal information for secondary purposes such as direct marketing.

Options to Limit the Way we Use Your Personal Information

If you do not want your personal information used in connection with direct marketing purposes, you may opt out or withdraw your consent to receive marketing emails at any time by clicking the "Unsubscribe" link provided in every marketing email, or by contacting us as provided below.

Additionally, to the extent permitted by law, you may revoke your consent to our use of your personal information by contacting us as provided below. Transfer of your Personal Information

As detailed in Section 5 of our Privacy Policy, we may share your personal information with certain third parties for our business and operational purposes. As most of these third parties are located in the United States, be advised that your personal information may be shared abroad.

Rights Under the LPD (Commonly Known as "ARCO Rights")

- 1. <u>Access</u>: You have the right to be informed of and request access to the personal information we have about you.
- 2. **Rectification**: You have the right to request that we update or correct your personal information.
- 3. Cancellation: You have the right to request that we delete your personal information.
- 4. **Opposition**: You have the right to request that your personal information not be used for specific activities.

## How to Exercise Your Rights

To exercise any of your ARCO Rights, please submit a request using the contact information set forth below. In order for your request to be considered complete, it must include the following: (i) your full name; (ii) your contact information (email address, phone number and/or mailing address); (iii) which right you wish to exercise; and (iv) a copy of an official government issued ID. Please note that we may need to verify your identity before we process your request. We will respond within twenty (20) business days from the date we receive your completed request, or as otherwise provided by law.
